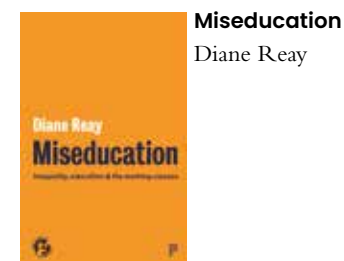
As changes occur in how work is organised across the globe, *What's Wrong with Work* shows that how workers are treated has wide implications beyond the lives of workers themselves.
